28 June 2023, Vienna, Austria

Background

The EU4Environment – Water Resources and Environmental Data programme aims at improving people's wellbeing in EU's Eastern Partner Countries and enabling their green transformation in line with the European Green Deal and the Sustainable Development Goals (SDGs). The programme's activities are clustered around two specific objectives:

- 1) support a more sustainable use of water resources and
- 2) improve the use of sound environmental data and their availability for policy makers and citizens.

The programme is implemented by five Partner organisations: Environment Agency Austria (UBA), Austrian Development Agency (ADA), International Office for Water (OiEau) (France), Organisation for Economic Co-operation and Development (OECD), United Nations Economic Commission for Europe (UNECE).

The programme is funded by the European Union and co-funded by the Austrian Development Cooperation and the French Artois-Picardie Water Agency.

The implementation period is 2021-2024.

Expected outputs and outcomes for the meetings

- Review of progress in implementation since the end of the Inception Phase in June 2022.
- Feedback from senior EaP stakeholders on implementation to date and strategic advice towards planning the next implementation phase of the EU4Environment Water & Data Programme.
